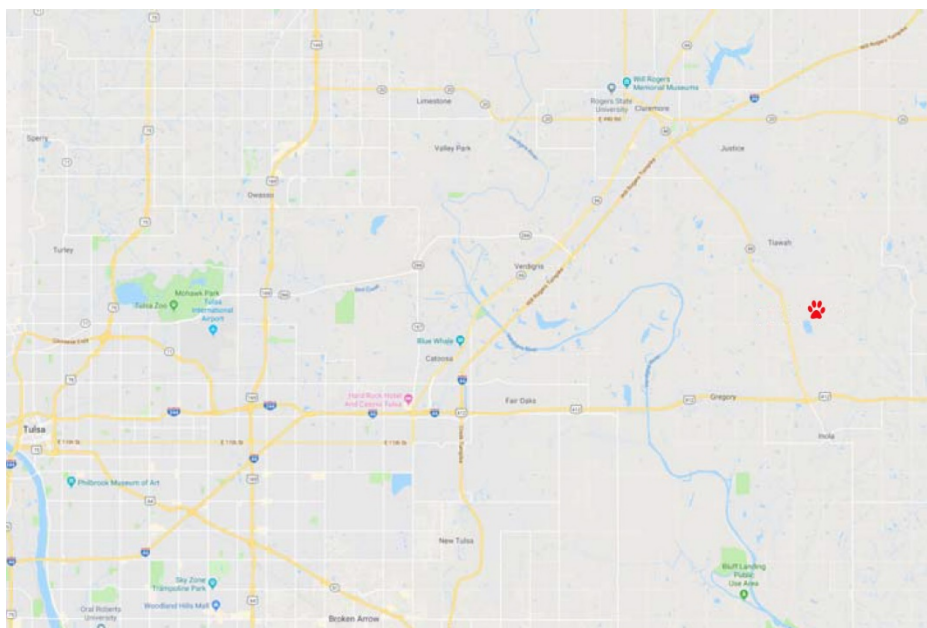

**From I44 East:** Take Highway 412 East out of Tulsa. Take Highway 88 Exit towards Claremore (north). Drive 2 miles to 560 Road and turn right. The grounds are 1.5 miles from the turn.

**From I44 West:** Take Exit 255 Take Highway 88 South for 10 .6 miles to East 560 Road. Turn left on East 560 Road. The grounds are 1.5 miles from the turn.
